

2026-2027 Product Program Participation Permission Form

My Girl Scout(s), _____, registered member(s) of Girl Scout Troop # _____, or Individually Registered Girl Scout(s) also known as a Juliette, has/have my permission to participate in the 2026-2027 Girl Scout Product Program season.

As the responsible caregiver for the above listed Girl Scout(s), I agree to the following:

- Adhere to the 2026 Product Program season dates:

Fall Product Program: September 4, 2026 - November 6, 2026 with money due November 9, 2026

Cookie Program: December 15, 2026 - March 21, 2027 with money due weekly w/final date March 22, 2027

- Take financial responsibility for all Girl Scout product picked up for my Girl Scout. **I understand that Girl Scout product cannot be returned to the Troop or the Council.**
- Count Girl Scout product and/or money with the Troop P/Council Product Manager and **sign and save a receipt each time** I pick up product or turn in money. If I do not count the product and/or money and sign a receipt, I will be responsible for any discrepancies in product and/or money reported by the Troop/Council Product Manager.
- Be responsible for the Girl Scout product and/or money lost, damaged or stolen while in my possession. A filed Police Report or insurance claim will be required to be relieved of any financial responsibility due to loss, damage or theft.
- Be responsible for turning in all money due for each program deadline(s) to the appropriate Troop/Council Product Manager. Failure to turn in all monies owed may result in collection/legal action and all product program credits, recognitions and Elite Entrepreneur Experience invitations will be withheld.
- Not combine sales with other Girl Scouts who do not live in the same household.
- Only sell online using my M2 and/or Digital Cookie site.
- Not post sales links or qr codes to any online resale sites.
- Follow the GSUSA and Internet provider guidelines when using the internet as a marketing tool for Girl Scout product programs. GSUSA Guideline resources can be located at www.kansasgirlscouts.org in the cookie seller resources section under the Cookies & Fall Program tab.
- Not sell Girl Scout product to third party re-sellers, i.e. Amazon retailers, store front businesses. Any resale or redistribution is prohibited as per GSUSA and vendor rules. Girl Scout product packaging clearly states that resale is prohibited.
- Not sell Girl Scout product in any commercial or family owned settings without my Girl Scout present. Even if family owned, my Girl Scout may not sell Girl Scout product at liquor stores, bars, gun shows, casinos, smoke shops or any other locations deemed inappropriate by GSUSA and Girl Scouts of Kansas Heartland.
- Not sell Girl Scout product that has surpassed the **Use or Freeze By Date** clearly stated on each package.
- I acknowledge that if a personal credit card reader; i.e. a Square, Venmo, CashApp, etc, is utilized, that all credit card or bank transaction fees are the responsibility of the owner of the device/account.
- I understand that if recognition choices are not made by the program end date, the council default item will be selected on my Girl Scout's behalf. All recognition/event choices will be final on each program end date.

Unpaid Balance Policy and Procedures

I understand that the monies collected for the 2026-2027 Girl Scouts of Kansas Heartland Product Programs are due to the Troop/Council Product Manager by the following dates:

- Fall Program: November 9, 2026
- Cookie Program: March 22, 2027

If the Girl Scout Product Program monies are not turned into the Troop/Council Product Manager, I understand that I will be turned over to the Girl Scouts of Kansas Heartland as a caregiver/adult with an unpaid balance.

As the caregiver/adult with an unpaid balance, I will receive a letter with the amount of the unpaid balance, with and extended payment date of three weeks from the date of the letter, or the opportunity to establish a payment plan. If the amount due or a signed payment plan agreement received within the three week period, I understand that I may be sent to a collection agency. If my debt is submitted to a collection agency, I will no longer have contact regarding the matter of the unpaid balance with Girl Scouts of Kansas Heartland and will have direct communication with the collection agency.

I understand that once the unpaid balance amount is sent to the collection agency, my Girl Scout, as well as other Girl Scouts physically residing in the same household, will not receive product program credits, product program recognitions, and any Elite Entrepreneur Experience Invitations and the troop and/or service unit will not be paid the proceeds from her participation.

I understand that any unpaid balance due must be paid in full, including any additional collection fees, before my Girl Scout or Girl Scouts in the same household are allowed to participate in any further Girl Scouts of Kansas Heartland product programs. This does not restrict my Girl Scout from participating in all other Girl Scout activities, i.e. troop, summer camp, registering for Girl Scouts, etc.

I understand that any unpaid balance regarding my Girl Scout or other Girl Scouts in my household, will place myself on a financial restriction prohibiting my ability to be a Product Program Manager and or GSKH Checking Account signer for the organization.

I understand that by signing the front page of this form that I have received a copy of this form and have read, understand and agree to all the rules and guidelines stated on the front and back of this Product Program Participation Permission Form.
