The last day of the 2025 Cookie Program is **Sunday, March 23**. We are all in the last few days of wrapping things up. With only five days remaining, things to think about before the last day are here:

- Do you have inventory that still needs an exchange?
- Do you have all your Troop to Girl transfers caught up in Smart Cookies?
- Have you been to the bank to make Girl and Booth deposits?
- Do you have payments posted in Smart Cookies for each Girl Scout who has turned in money?
- Are there Girl Scouts in the troop you have not heard from for a couple

of weeks? Or maybe not since they picked up cookies? RED FLAG!

- Does your Troop On Hand Report match your actual product inventory?
- Have you pulled your All Orders Data Report from Digital Cookie and accounted for all In-Person orders/donations and Donations (Care & Shares)?

As you prepare for the 2025 audit process, be sure and refer to the <u>audit process</u> <u>checklist</u> located on our website. The audit link will be <u>available March 24 at 5</u> **p.m.** This one day delay gives Digital Cookie the time needed to sync with Smart Cookies and ensure all transactions are accounted for.

About Your Inventory

If you have inventory that you are still needing to exchange at an Inventory Cupboard, we are in those final days, and will do so as long as we have the inventory on-hand.

If you have **damaged** product still in hand, this can only be managed at an Inventory Cupboard. We can exchange or give credit back to the troop. Only Troop Cookie Managers are allowed access to the cupboards. If another is coming in your place you still need to notify the location who is coming and what they are allowed to do.

Everything for walk-ins is first-come, first-served status and inventory is what we have. We want to encourage all to continue to utilize the **GSKH Cookie Swap** group and help each other where you can.

Beginning March 17, the Wichita Inventory Cupboard has been re-located to the council office: 360 Lexington Rd, Wichita, KS. All other inventory cupboards are still at current locations with adjusted hours.

All Inventory Cupboards are open Saturday, March 22: 8 to 11 a.m.
