The first ACH Debit information notice should have hit Troop Cookie Manager's inbox yesterday evening (Monday, February 26). This deadline and its timing should not be a surprise. Pages 4 and 5 of [*TroopCookies, Inc.*](#) provides the timeline and page 9 of *TroopCookies, Inc.* will give you a deeper understanding of the first payment process. Check your Troop Balance Summary report in Smart Cookie and/or the email sent to your Troop Cookie Manager for the financial details.

Remember: Your Troop Balance Summary may be different with regards to the amount of credit card payments applied. The receiving of these payments is in

constant motion and the amounts may be different from the time this information was gathered for the email you received.

Planned Orders

The Planned Order scheduled for Sunday, March 3 at midnight will be this seasons **last planned order**. As you may have noticed, Adventurefuls, Toast-Yays! and Gluten Free are no longer available on the Planned Order grid. We do expect these varieties to flow in-and-out of the inventory cupboards through exchanges beginning with this week's Planned Order requests, but we have no way of knowing for certain what those numbers will be. Be certain to continue to list in the comments section the number of packages still needed of these varieties and we will process what we can as they go in-and-out of cupboards.

Reminder: The council has made its **final** inventory purchase for the season. We will do our best to accommodate everyone's March 3 Planned Order requests, but is important to know now that your orders may be reduced.
