National Council Session is schedule to be held in person approximately July 20-25, 2026 in Washington, D.C.
*Specific dates/times are not available at this time.

Delegates and Alternates to the National Council must be registered members of Girl Scouts of Kansas Heartland, Inc. (GSKH), United States citizens, and at least 14 years of age at the time of election. Delegates and Alternates must commit to participating in preparatory meetings, attending national council sessions, and communicating with GSKH membership. The term of office is three years or until their successor is elected. GSKH will pay up to \$2,000 (approximately 2/3 of the cost) for elected delegates' travel, registration, hotel, meals, and other considerations for the 2026 National Council Session in Washington, D.C. Delegates are personally responsible for additional costs of attending the National Council Session and National Convention as well as all costs associated with activities outside the scope of the National Council Session. Youth delegates may use Program Credits toward costs of the National Council Session. Alternates may attend and would be responsible for the full costs.


