Delivery and Distribution

Delivery trucks out and about with the Initial Order should be wrapped up by Thursday, February 12! Thank goodness for glorious weather for a change. You should have already heard from your Delivery Stations Manager (DSM) via communications outside of Smart Cookies. As soon as troops receive cookies they can begin distributing to girls. Girls may begin delivering their pre-orders to their customers upon receipt of their initial orders. Girls may also begin selling and adhere to the same date as troops when selling in a booth/pop-up stand environment.

Planned Orders

Planned Order #2 : Opens at 5 p.m. CT on February 11, is DUE on Sunday, February 15 by 11:59 p.m. CT, and will be available for pickup on February 20-21 by appointment. If someone other than the Troop Cookie Manager (TCM) will be picking up the order, you must indicate this in the **comment portion** of the Planned Order when placed. The order will not be allowed to be picked up without prior knowledge.

SPECIAL NOTE: For those utilizing the Great Bend Express, please note that this Planned Order location is **only** available during the Planned Order #2 process.

Booths



This first day for Pop-Up Stands and Troop Booth location availability is Friday, February 13. Just in time for Valentines Day! So don't forget to make up a few decorative "Chocolate Lover's" bundles for that quick gift on the grab.

And don't forget the next round of FCFS booth choices is also available. Check the bottom left corner of your Troop Action Calendar for details.

The Dillons, Walmart/Sams, and Wendy's locations you currently see in Smart Cookies have responded and indicated the dates and times for booth availability. We will continue to make location available as their information is received. You

may approach your favorite Dillons location for a Troop Secured request through Smart Cookies if it is not yet present, but it is important for all to understand that Walmart/Sams Clubs and Wendy's **should not** be approached due to the national contract and directed process that exists between them and GSUSA. On a side note, if your favorite Walmart is not yet listed, it may be because that location is currently in a remodel phase and has indicated they will not allow booths this season.

What I should know...

As product is being delivered and distributed to our Girl Scouts, be aware that with close to a million packages across 80 counties, it is inevitable that there will be damaged product. Everything from a package not sealed properly, to missing packages within a case or even some packages not sealed properly or at all.

The process is to retain these packages, as they contain numbers on each package that will need to be communicated to the bakery. These packages should be returned to an inventory cupboard to be replaced.
